The meeting commenced with recitation from the Holy Quran by Mr. Badre Alam.

Thereafter, the proceeding on the Agenda of the Meeting started seriatim as under :-

01. TO ELECT OFFICE BEARERS (CHAIRMAN, SENIOR VICE CHAIRMAN AND ONE VICE CHAIRMAN) OF PAKISTAN TANNERS ASSOCIATION (CENTRAL), FOR THE YEAR 2017-2018 TO TAKE THE CHARGE OF THEIR RESPECTIVE OFFICES W.E.F. 1ST OCTOBER'2017 :
