THE COMMERCIAL COUNSELLOR OF THE PEOPLE'S REPULIC OF CHINA IN KARACHI VISITED PTA CENTRAL OFFICE

At the instance of PTA, Mr. Yan Jianming, Commercial Counsellor of the People's Republic of China alongwith Mr. Xu Runtao, Consul visited PTA (Central Office), DHA, Karachi on 8th May'2014 and held meeting via video conference with members from PTA (SZ) and PTA (NZ) to discuss bilateral trade between both the brother countries.

Sh. Saqib Saeed Masood, Chairman, PTA, Mr. Gulzar Firoz, Chairman, Diplomatic Affairs Standing Committee and members from PTA (NZ) Lahore, Mr. Muhammad Musaddiq, Mr. Agha Saiddain and Mr. Shahid Usman thanked the Commercial Counsellor for sparing time to meet PTA's members. They also expressed pride on long historical friendship of Pakistan and China and appreciated Chinese policies and their Government support for the development and promotion of Pakistan's economy,

Mr. Yan Jianming, Commercial Counsellor of the People's Republic of China also thanked the Chairman, PTA and members for arranging a get-to-gather meeting in his honour to discuss enhancement of bilateral trade. He assured his full cooperation and continued support for strengthening their trade relations and friendship between the two countries on cordial footings.

The Chairman, PTA stated in his welcome speech that despite a friendly country, PTA member exporters are facing a lot of problems in exporting their products to China. He also drew attention of the Chinese Commercial Counsellor towards various problems and issues of leather industry in respect of trade with China. Members also offered different proposals/suggestions for the enhancement of export of Pakistani leather & leather products particularly Raw and Finished Leather, Footwear & Gloves to China.

We illustrate hereunder proposals/queries raised by the Chairman, PTA, Chairman, Diplomatic Affairs Standing Committee and Members during the meeting as well as response received from the Commercial Counsellor in this regard:

To increase volume of export of Leather & Leather Products into China presently Pakistan's export is less than 1% of the total import of China at US\$ 10 Billion while the Pakistan produces best quality leather and stood at No.2 after Italy. Pakistan has huge livestock including Buffalo, Cow, Goat and Sheep particularly best Buffalo available in Pakistan which is 14% of the total global population. Pakistan needs greater trade access for Raw, finished leather, Shoes and Gloves to the Chinese market.	Mr. Yan Jianming, Commercial Counsellor stated that China always supported Pakistan as brother country. He appreciated the international quality standard of finished leather produced by Pakistani Tanners which would certainly be of value for Chinese buyers to get it from Pakistan. He also informed that due to environmental obligations of WTO in China a number of small tanneries have been closed down resultantly the manufacturers are facing short fall of raw materials. Definitely they will move to Pakistan for importing needed raw materials for manufacturing of Garments, Shoes and other Leather products.			
		He apprised the members that the export of good quality of Leather from Pakistan and import of China can be enhanced with still more improvement in value addition and quality.

To ensure implementation of Zero Rating Import of Leather into China under 2nd Phase of Pak-China FTA as PTA already sent proposal for zero rating to	The Commercial Counsellor informed that the tariff will be reduced gradually through bilateral conversation. He also assured that the issue will be again taken-up with the Commercial Section of the

Mr. Yan Jianming clarified that Chinese Government is supportive of better access for Pakistani products and always supported business community in this regard. Recently China committed to invest US\$ 25 Billion in Power Sector as well as other sectors in Pakistan. He realized that there is a great potential to enhance export of Leather, Leather Footwear and Leather Gloves to China for which there is a need to establish joint ventures b/w both the countries for economic cooperation on very big platform. He assured to motivate Chinese Business Community and Chinese Government for having collaboration with PTA's members.			
4.	To issue Multiple Visit Visa for atleast 6 months instead of 3-months.	Regarding issuance of Multiple Visa to Pakistani exporters of Leather & Leather products, Mr. Yan realized the gravity of the situation and assured to discuss the matter with the Chinese Consul General to issue visa on PTA's recommendation like FPCCI & KCCI.			
5.	To send and Receive Trade Delegations of Leather & Leather Garments / Leather Products to China and from Pakistan to explore more business avenues.	He appreciated PTA's proposals for exchange of Visits of Trade delegations, views, updated market information, list of Chinese importers of Leather & Leather Products etc. He assured to extend maximum possible cooperation in this regard for expansion of exports from Pakistan. He also advised to move the above proposal through the Ministry of Commerce to Chinese Government for consideration.			
6.	To recommend for offering free booths in any potential event of Leather and Leather Products to be held in China like KUNMING Fair presently scheduled to be held from 6-10th June'2014 as recently offered to TDAP.	The Chinese Commercial Counsellor assured that regarding allocation of Free Booths to Pakistan exporters of Leather he will forward his recommendation to the Chinese Organizer concerned to pay their attention on Pakistan's participation as they desired. He stated that both the countries are brothers and any requirement from Pakistan's side will be taken seriously.			
7.	To invite Chinese enterprises i.e. Leather Shoes and Machineries to participate in proposed Pakistan Mega Leather Show to be held from 26-29th January'2015 in Expo Centre, Lahore.	Mr. Yan Jianming assured to extend cooperation by putting down information of Pakistan Mega Leather Show in their Official Website as well as motivating Chinese Enterprises to participate in the said Fair in Lahore.			
8.	To open Chinese Consulate Office in Lahore as presently business community has to visit Islamabad for issuance of Visa at their each business trip to China which create hurdles, wastage of time and money.	The Chinese Commercial Counsellor realized the grievances being faced by the Exporters of Leather from Lahore due to non availability of Consulate Office in their city and they have to visit Islamabad for the purpose. He assured to make recommendation to Chinese Government for opening a new Chinese Consulate Office in Lahore for easy access of the Punjab based businessmen. He also advised to move the said proposal through the Ministry of Commerce to Chinese Government with strong recommendation.

9.	To communicate Chinese Government to allow Shipments of Pakistani Leather & Leather Products directly to China instead of via Hong Kong where these are un-necessary stuck-up for long time.	Mr. Yan Jianming informed that he will forward the proposal of Pakistani exporters to the authority concerned of China to allow arrival of shipments from Pakistan at specific destination to China instead of Hong Kong.

- To release all Pending subsidies of participation of PTA members in various Int'l Fairs.
- To include representatives of Pakistan Tanners Association (from Leather Sector) on the Export Committee on Leather, which is being formed by CE/TDAP to sort out the grievances sector wise for prompt redressal.
- To remove 3 years condition of participation from TDAP's rules
- To revise Duty Drawback Rates of Leather.
- To change date of Applicability of SRO 897(I)/2013 from 12th June'2013 instead of 4th October'2013.
- To include Hides & Skins in 6th Schedule of Sales Tax Act 1990

- To reduce Custom duty on basic Chemicals used in tanning Industry.
- To induct PTA Chairman in EDF Board.
- To release Pending Sales Tax and Duty Drawback Claims of PTA's members.
- To make strong recommendation for inclusion of PTA's proposal for Budget & Trade Policy for the year 2014-15.
- To execute 2nd phase of FTA with China with the assurance to implement Zero Rating import of leather into China from Pakistan and also to negotiate with Japan & South Korea for the reduction of custom duty on leather into these destinations, as India has already got custom duty relaxation on Leather in Japan & South Korea.
- Holding of Pakistan Mega Leather Show from 26-29th January'2015 at Lahore Expo Centre, which would be jointly organized by PLGMEA, PFMA, PGMEA & PTA to display entire products/leather under one roof to attract the foreign buyers/customers.
- Increase of Government financial support upto 75% on participation in Int'l Fairs.
- Allocation of sufficient fund from EDS for Leather Sector for the promotion & marketing internationally. After hearing all the problems/grievances of the leather exporters patiently Mr. S. M. Muneer, Chief Executive, Trade Development Authority of Pakistan issued necessary directives to the concerned Directorates of TDAP to take prompt actions thereon and to submit the progress report to him as soon as possible. Mr. S.M. Muneer assured PTA's Delegation that all the genuine proposals/suggestions being productive for the promotion of country's exports would certainly be considered favourably by TDAP with the supreme motive to provide level playing field to enable PTA's member exporters to play their vital role more vigorously and enthusiastically for the uplift of leather industry.

Mr. Gulzar Firoz, Former Chairman, PTA and Ex-Vice President, FPCCI also moved their proposal for holding Expo Pakistan 2014 in Karachi Exp Centre in a more transparent method to become more result oriented specially to invite potential foreign buyers/customers after exercising thorough scrutiny so that the objectives for holding Expo Pakistan would be achieved for which Mr. Gulzar Firoz offered his services & expertise to TDAP in this regard.

Mr. Amanullah Aftab and Mr. Habibur Rehman Sheikh also shared their views with the house specially for organizing National Pavilions and to form Trade Delegations to the potential new global markets to explore business avenues.

The Chief Executive, TDAP, Mr. S.M. Muneer was thankful to the PTA's Delegation for highlighting the issues and viable proposals/suggestions as well as potential areas for

the promotion of country's exports and assured firmly to Sh. Saqib Saeed Masood, Chairman, PTA to proceed together to avert all the bottlenecks faced by PTA's members for the growth of business & promotion of the country's exports.

At the conclusion, Sh. Saqib Saeed Masood, Chairman, PTA thanked Chief Executive, TDAP, Mr. S.M. 01. To instruct the Turkish Customs authorities to wit draw collecting 3% Import Duty on Leather from Pakistan which is

ollecting 3% Import Duty on Leather from Pakistan which is contradictory against the Turkish Government's decision for allowing "0%" Import Duty on Pakistani Leather.

- 02. To apprise the Turkish Customs authority that the LAB Test is not mandatory for Turkish buyers / customers on Import of Leather specially from Pakistan as it is already mentioned on their Invoice that "Prohibited Chemical is not used in this Leather" which should be accepted as in the case of European Union which do not require any Lab test of the goods on import.
- 03. To make recommendation to the Fair Organizer concerned for Concession in the Stand Rental preferably upto 50% for participation of PTA's members in 52nd AYSAF Fair to be held from 3-6th December, 2014 at Istanbul, Turkey.



- 04. To exchange the Buyers/Customers Data of Turkish manufacturers of leather shoes, leather garments, leather bags/products with PTA to facilitate direct access to them for collaboration/business ties.
- To supply the detailed information about the utilization of Free Trade Zones in Turkey to have understanding for massive marketing.

Mr. Sercan Celik, Turkish Vice Consul after patient hearing assured his support and cooperation in exchange of information b/w both the countries with the aim to boost bilateral trade. He also assured to discuss PTA's proposals/issues with the Turkish Consulate as well as with Turkish Customs authorities concerned for implementation of 0% import duty on Pakistan Leather.

ROYAL LEATHER INDUSTRIES WON FPCCI'S GOLD MEDAL FOR CSR

PTA's prominent member M/s. Royal Leather Industries Ltd., Lahore was awarded a Gold Medal by the FPCCI on Corporate Social Responsibility (CSR) in compliance with national environmental quality standards for "Zero Discharge" of wastewater on the occasion of FPCCI's 37th Export Awards Ceremony held in Lahore. It is the first tannery in Pakistan to have achieved this award.

ENVIRONMENT COURT APPRECIATES THE PERFORMANCE OF ROYAL LEATHER INDUSTRIES LAHORE – PAKISTAN

Royal Leather Industries of Pakistan received an Environment Protection Order under section 16 of Punjab Environment Protection Act 2012, from the Provincial office of Environment Protection Department (EPD) Punjab to adopt remedial measures to abate pollution in conformance with National Environment Quality Standards (NEQS), prescribed under the law. Accordingly the case was forwarded to Environment Tribunal Punjab for want of appropriate legal measures against Royal Leather Industries. Environment Tribunal summoned Royal Leather Industries to present the defense against charges imposed by EPD.

Mr. Agha Saiddain, Director Marketing of Royal Leather Industries appeared before the Tribunal in person and presented his defense statement and denied all the allegations of EPD Punjab and condemned the complainant for singly pointing out a tannery that has won the internationally recognized 'Asia's Best Tannery Award' in 2013. He invited the members of Environment Tribunal to pay visit to his factory.

Accordingly the learned members of Environment visited the said tannery and after knowing the facts presented on ground decided to dismiss the case against Royal Leather Industries.

THE DECISION OF THE TRIBUNAL READS AS UNDER

"In the noted above circumstances, the Complaint case in hand is hereby **DISMISSED** in capital words, with direction to the Complainant/EPA to take disciplinary action against its District Environment Team, which seems sleeping over wide spread pollution and destruction of environment caused by a large number of other industrial Units in the area and have singled out and reported bad picture of the respondent industrial Units for legal action without any scruple of conscience. This order be immediately notified to all concerned. File be consigned to record".
