SUB : WITHDRAWAL/HOLDING IN ABEYABNCE OF PTA'S ANNUAL ELECTION 2023

Dear Sir,

Kindly refer to PTA's letter # **130/2023/80 dated 27th July, 2023** with subsequent reminder (**copies enclosed for review/reference** and Reply thereto has not yet been received) with the announcement of Election in **Pakistan Tanners Association** bearing License # 82 in compliance with rules/TOR 2013 under section 29(b) (iii) laid down in PTA's Memorandum and Articles of the Association, PTA.

Thereafter, further proceedings were made specially the matter for 2 years tenureship was subjudized in IHC and necessary hearing thereon were held and accordingly issued **Stay Order # 1 dated 13.07.2023 Stay Order # 2 dt. 16.08.2023 (copies enclosed)** and accordingly MOC's has also issued necessary amendments letter dt. **08.08.2023 (copy enclosed for reference)** while in final mode with updated version a Summary was also **issued on 17.08.2023 (copy enclosed for review/reference)** having categorical clarifications for continuation of tenureship with certain advices made thereon clearly for the suspension of **Election this year 2023** and existing CEC with office bearers would continue upto 2024 with designated responsibilities of the Association.

In this context, after detailed discussion and deliberation, the **Pakistan Tanners Association (PTA)** has unanimously decided that the proceedings of "**Elections 2023 in PTA**" shall remain **held in abeyance till the final decision/verdict of the IHC**. The decision was made based on the facts and paper evidence available with us and considering that the matter is pending in the IHC. In the meantime, the existing CEC Members and Office Bearers elected for the year 2022-23 will continue their responsibilities. **Mr. M. Mehr Ali will remain the existing Chairman of PTA, Mr. Muhammad Shafi will continue as the Senior Vice Chairman, and Mr. Fazlur Rehman Shaikh will remain the Vice Chairman of the Pakistan Tanners Association.**
