He further said there is no mechanism as how an importer will claim refund of sales tax due to the reason that this imported material is purchased by small tanneries that produce leather and sell same to the exporters in Sialkot and other markets, he added. Agha Saiddain said that FBR had reduced the duty drawback rates without any justification. After a long exercise of three years, the IOCO (Input-Output Coefficient Organization) finalized the duty drawback rates and forwarded to FBR for implementation.
